## Our Program

*Friends of the Children – Portland* is a revolutionary mentoring program. Our mission is to provide our most vulnerable and challenged children a loving, caring, nurturing and sustained relationship with an adult role model who teaches positive values and has attainable expectations for each child to help them become healthy, productive members of our community.

## Our Story

Friends of the Children was founded in 1993 by entrepreneur Duncan Campbell. Campbell was inspired by his own troubled childhood to start a revolutionary new program to help at-risk children in the same neighborhood where he grew up. We began with 3 mentors (called Friends) serving 24 children in northeast Portland, and today we serve 270 children in over 90 schools across the Portland metropolitan area and have been replicated by chapters in 8 additional communities across the country.



## Our Children

Our children have a high degree of vulnerability to school failure, gang and drug involvement and teenage pregnancy. Many of our children have faced poverty, homelessness, neglect, abuse, foster care, parental incarceration, drug and alcohol abuse and domestic violence. We work with our children from the time they are selected in kindergarten through their high school graduation date.

## Our Friends

Full-time, paid, professional mentors, called Friends, spend a minimum of four hours every week with each child they mentor, teaching valuable life skills, instilling positive attitudes, and helping our children grow into responsible adults.

## Our Goals

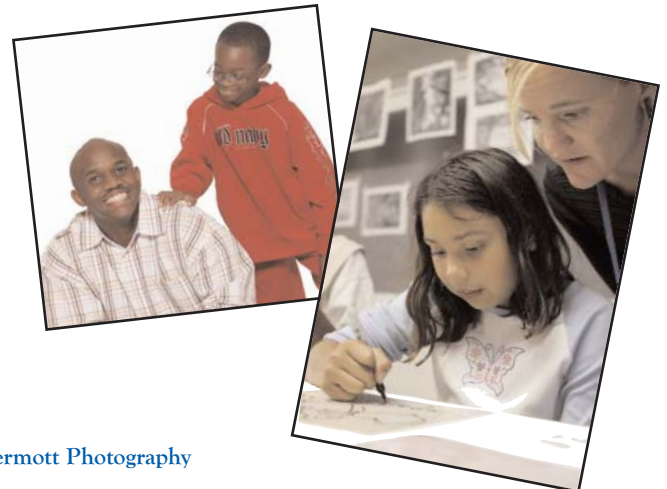
We want each of our children to have a bright future, and we believe they can. Our work is guided by three long-term goals that we set for each child in our program:

- Succeed in school with the completion of a high school diploma or GED.
- Avoid involvement in the criminal justice system.
- Avoid early parenthood.

## Our Happy Endings

Children involved in Friends beat the odds! Of the 270 youth currently in our program:

- 80% do not use drugs or alcohol on a regular basis.
- 92% are not involved with the juvenile justice system.
- 96% of all program children are in school and attending regularly.

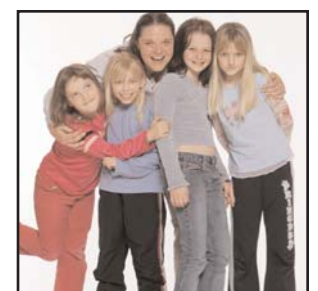

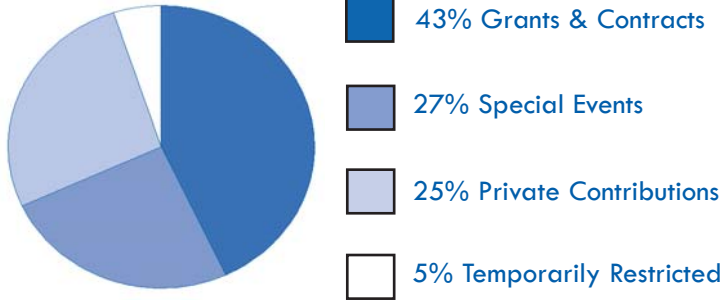




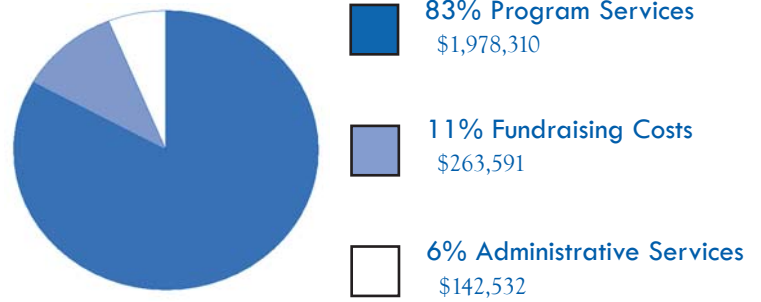
